Note:

- 1. Administrative Secretary Incharge ACB shall initiate the APRs of the Director, ACB only in case his year of allotment is earlier than that of the Director, ACB. In case, the year of allotment of Director, ACB is earlier than that of Administrative Secretary, Incharge ACB, the APRs shall be initiated/reviewed by the Chief Secretary and accepted by the Hon'ble Chief Minister.
- 2. Administrative Secretary Incharge ACB shall review the APRs of IGP, ACB only in case his year of allotment is earlier than that of the IGP, ACB, otherwise the reviewing and accepting authority will be the Chief Secretary.
